In addition to arbitration, James also has long experience of litigation from three different jurisdictions: Scotland, England and now Sweden.

As well as having a busy practice, James is a guest lecturer in arbitration at Stockholm and Uppsala universities. He is also co-chair of the research panel of arbitration and other forms of dispute resolution at the Stockholm Centre for Commercial Law (SCCL).
